NCBA Account

Rodney shared that the clinic is running within budget and can purchase music at a reduced price and this will keep the event from running financially into the red. Chris also added our appreciation to Dr. Caldwell and the UNCG School of Music for their assistance with this event and alleviating potential costs.

Fran shared a comparison between costs from this year to last year. We are currently in a \$2000 deficit due to general cost increases. She reiterated to the group that NCBA handles our own money and we need to keep enough in the account to cover each district in the event it is needed. Fran shared that district assessments will go from \$1450 to \$2000. The fees haven't been raised in many years and were even cut during COVID years. This cost increase is to help support this fund. If it is determined that the amount catches us up financially, the board will revisit and lower next year.

Discussion: It was recommended that clinician assistants send a list to directors to borrow music to save purchasing money. Issues occur when the music list from conductors are not received in time to order and an e-print must be purchased.

Honors Band Committee Report

The committee decided in November to absorb the timpani tuning portion of the audition into the solo and the sight reading. The committee will revise the score sheet to reflect these changes. They will still be scored on tuning but it will not be a separate category.

The committee unanimously agreed that the horn solo be shortened.

String bass solos need to be revised. The committee is gathering college professor feedback.

The committee received a request that sight reading criteria be formalized so that students know what to expect. The committee will proceed with this request.

Mark Norman from the Piedmont Wind Symphony asked if we would like a concert on the Saturday of All State. Question for the membership, would this be valuable or are students tired and ready to participate in their school traditions? Dr. Caldwell says the school can support this. This would be a required part of the clinic.

Membership discussion:

- Issues with prom
- Students are exhausted
- The interruption of traditional activities that students are accustomed to participating in with their schools
- No exemptions would be allowed

Majority of membership wants to keep the schedule of events the same and not add any additional activities for students. Jim thanked the membership for their discussion.

Audition registration deadline is solid and directors are expected to follow those dates. Membership shared concerns about everyone within each district being reminded about registration and deadlines.

The district clinic chair is responsible for cancellations and communication with the audition chairs. Remember to talk to your students about their commitment to attending. Nominations for Hall of Fame Class of 2026

- Nominator and District Chairs use the <u>Eligibility Requirements and Nomination Procedures</u> to ensure candidates are eligible for nomination.
- Nominator uses <u>Nomination Required Materials Checklist</u> and submits materials to district chair
 - O District Chairs set submission deadline for their district
- District chair then completes the official Online Nomination Form by July 1, 2025
- Hall of Fame Committee meets in summer to review materials and prepare the nomination ballot
- President-Elect notifies nominees of their voting status after the Hall of Fame Committee meets
- General membership votes on candidates at fall meeting in November

If someone wants to nominate, they need to go to the district chair ahead of time so that the chair can get them turned in by the deadline.

Program of Distinction Proposal

Membership Discussion / Vote

Paper ballots were distributed. Motion and second to accept the proposal as listed.

Discussion Points:

- The document can be presented to the Principal if they need to know what a program should look like
- Appreciation for the effort that went into this
- When would this take effect? 2025/2026
- Who will evaluate all of this? Band delegate
- Who will help/assist the band delegate? That will be organized if this passes.
- The changes that have occurred are more inclusive of all school/program sizes
- If this is passed, could there be support for new directors taking over programs of distinction?
- Thanks for all of the input and to the committee for their work
- How long does the "distinction" last? Is this each year? Yes. Directors apply every year.
- Will there be a fee for this? Not as of now.
- Reservations, there are possible negative repercussions that could be to serve as a resume booster or ego builders for directors, then this isn't serving the education purpose with what is intended.
- As it builds one program, it could be detrimental to another and turn into negative pressure.
- The list of options within this proposal recognizes what is already happening within bandrooms.
- Where does the proposal stop? When does it end? Where does this go, policy & procedures? Who is responsible for updating, adding, changing?

Discussion closed.

- Rewording of Marching Band Committee Description
 - Section 4. The NCBA Marching Band Committee will oversee all NCBA sanctioned Marching Band Competitions across the state, create and administer the procedures related to Concert Band MPAs standards and adjudication, and edit the Marching Band Competition and MPA Procedures Adjudication Manual as needed. The NCBA President is an ex officio member of this committee.
 - The Board can change this wording without discussion as long as it's reported to the membership after the change since it's understood this is a grammatical mistake (Marching Band has no connection to Concert Band MPA)
